Agenda Item IV. Keith Rovira, CPA, Louisiana State Auditor, Finalization for 2017 Annual Audit

- Louisiana State Auditor, M Rovira stated that that Library Board President, Virgie
 Johnson and Library Director, Trina C. Smith had acknowledged the findings of this
 year's audit as part of the Discussion Draft.
- On behalf of the board, Mrs. Johnson and Board Treasurer, Brannetter James provided the Management Corrective Action Plan Response for next year's audit to Mr. Rovira.
- Mrs. Coy expressed that she had not received a copy of the plan prior to the meeting.
 She asked if she could have 5 minutes to read through the findings.
- Mr. Rovira stated that he will forward the 2018 Agreed Upon Procedures to Ms. Smith.

- Mr. Rovira read through the list of items that passed the audit with No Exceptions, such as bank and account reconciliations, bonds, contractors, personnel.
- He mentioned that daily funds need to be deposited the same day, and that no one person can count, verify, and deposit funds.
- Monies from the Sheriff's Office are being mailed, but Ms. Smith stated that she was waiting to hear if they provide an ACH transfer service.
- Mr. Rovira's recommends a computerized accounting system for accountability and accuracy.
- He verified that electronic signatures are password protected only by the Business Manager.
- Mrs. Coy pointed out a misprint about deposits being made weekly instead of daily.
- Mrs. Coy asked about fund limits for contracted services. The amounts are cumulative for the year and not individual transactions. Mrs. Smith referred her to the Louisiana Legislative website under Public Bid Laws to read the threshold amounts for contracts.
- Mrs. Lisa Tregre-Wilder requested a list of contractors the library is currently working with.
- Mr. Rovira stated that there were No Exceptions for leave records, time, Ethic Certificates, and personnel, all that were in compliance.
